BY SIGNING THIS DOCUMENT I AGREE in consideration for my participation in this Competition at Fox Lea Farm to the following: BY SIGNING THIS DOCUMENT I AGREE AND ACKNOWLEDGE that horse sports involve inherent dangerous risk, and by participating in horse sports and related activities such as horse care and horse shows and the like the undersigned expressly assumes any and all risks of injury or death during or in connection with any horse activities at Fox Lea Farm, 800 North Auburn Road, Venice, Florida. THE UNDERSIGNED FURTHER AGREES that should any loss, injury or death suffered by the undersigned or the child or dependant he/she is signing on behalf of as well as their horse(s) or other pet(s) or by guests, trainers, coaches, agents, or relatives accompanying he/she while at Fox Lea Farm that he/she by participating in horse related activities expressly assumes all responsibility for loss, injury, or death and agrees to hold Fox Lea Farm, Inc. its owners, directors, agents, employees and guests harmless should loss, injury, or death result, directly, from the negligent acts or missions of Fox Lea Farm, Inc., its directors, its agents, its employees and its guests. BY SIGNING THIS DOCUMENT I AGREE that I choose to participate voluntarily in the Competition with my horse, as a rider, driver, handler, vaulter, longeuer, lessee, owner, agent, coach, trainer, or as parent or guardian of a junior exhibitor. I am fully aware and acknowledge that horse sports and related activities involve inherent risks of injury including broken bones, head injuries, trauma, pain, suffering, or death ("Harm"). BY SIGNING THIS DOCUMENT I AGREE to expressly assume all risks of Harm to me or my horse and for any Harm caused by me or my horse to others, even if the Harm resulted, directly or indirectly, from the negligence of Fox Lea Farm and David and Linda Aldrich. BY SIGNING THIS DOCUMENT I AGREE to indemnify (that is, to pay any losses, damages, or costs incurred by) Fox Lea Farm and David and Linda Aldrich and to hold them harmless with respect to claims for Harm to me or my horse, and for claims made by others for any Harm caused by me or my horse at the Competition. BY SIGNING THIS DOCUMENT I AGREE that while I am on the show grounds and mounted on any horse or pony that I will wear protective head gear. I understand that protective head gear can not guarantee that I will not suffer a trauma or injury if an accident may occur. If I am a parent or guardian of a junior exhibitor, I consent to the child's participation and AGREE to all of the above provisions and AGREE to assume all of the obligations of this Release on the child's behalf. BY SIGNING THIS DOCUMENT I AGREE that Fox Lea Farm and David and Linda Aldrich as used above includes all of their officials, officers, directors, employees, agents, personnel, volunteers and affiliated organizations. I further agree that if any damages shall be occasioned or loss occur, by fire or otherwise, to the horses exhibited, or to any vehicle or other article that I may send with such horses that I will make no claim therefore; and I further agree to hold this competition and Fox Lea Farm, Inc. and its owners harmless from any claim or demand of whatsoever kind or nature, that may be occasioned by the horse or horses exhibited by me, or the negligence of the persons in charge of such horses, and to repay to this competition, on demand, all damages it may sustain by reason of any claim or demand as aforesaid. I agree that if any damage shall be occasioned or loss occur, by fire or otherwise, to the horses exhibited, or to any vehicle or other article that I may send with such horses that I will make no claim therefore; and I further agree to hold this competition and Fox Lea Farm, Inc. and its owners harmless from any claim or demand of whatsoever kind or nature, that may be occasioned by the horse or horses exhibited by me, or the negligence of the persons in charge of such horses, and to repay to this competition, on demand, all damages it may sustain by reason of any claim or demand as aforesaid. Ultimately the final decision on whether ring conditions and weather conditions are safe for the rider, and horse/pony, belong to the trainers and exhibitors or those responsible for such decision for a minor exhibitor. I represent that I have the requisite training, coaching and abilities to safely compete in this competition. BY SIGNING BELOW, I further AGREE to be bound by all applicable Fox Lea Farm Rules and all terms and provisions of this entry blank. BY SIGNING BELOW, I further AGREE that I have been given permission to sign this form for whomever it may include, ie. owner, rider, trainer. The format of this liability agreement is related to the format and wording of the United States Equestrian Federation (USEF) recommended release for recognized shows, all wording related to the Federation has been altered to represent only Fox Lea Farm, Fox Lea Farm Inc., and David & Linda Aldrich for an unrecognized competition that has no connection to the USEF. We have asked permission of the USEF to use this style, formatting and wording. If we are not granted permission to use this form we will furnish a new liability release to all entering the show grounds at the show office.
