2. AWARDS: 1st thru 6th place ribbons and 1st place awards with 3 or more entries.

3. ENTRIES: Intro thru Fourth - \$45: FEI & Freestyles - \$65: Qualifying Fee \$10: Office Fee per horse/rider combination - \$20: USEF Drug Fee \$12: Non competing horse (schooling) \$25: Late entry fee \$10: each non USEF rider/trainer/owner must pay a \$20/\$5 (breed/disc), (\$20 for riders under 18) non-member fee, each non USDF rider/owner must pay \$20 non member fee: plus stall fee as below. Entries will not be accepted unless full payment of all fees plus certified copy of current coggins test, USDF/USEF member numbers and all releases properly executed and signed on entry form.

4. TIMES: Will be mailed to your winter address about 1 week before the show.

5. STABLING: 254 permanent stalls with doors are available. Stalls are 10X12 and 12X12. No first bedding is provided. Straw bedding is not permitted. Stall assignments at discretion of management. Shavings available on grounds \$7.75 a bag.
SHOW FEE: \$100 from noon day preceding show to show's end. Extra nights \$24. Show stabling rates of \$67 will apply to horses already boarding at Fox Lea Farm that are participating in show. All horses must be stabled. No dogs allowed in stalls.

7. CAMPER SPACE: Electric & water, no septic-**30 AMP \$35.00/night, 50 AMP \$45.00/night**

8. FOOTING: All arenas 20 X 60 meters. 4 sand with screenings. Ample warm-up.

9. DIRECTIONS: I-75, Exit 193(old exit 35)(Jacaranda Blvd). Turn right second light onto E Venice Ave. Turn right one mile onto Auburn Rd 1.2 miles on right

10 HOSPITALITY: Concession stand on grounds throughout show, breakfast available. Special events will be posted.

12.PETS: If a pet is brought to the show grounds, **IT MUST BE CONTAINED ON A LEASH OR IN A CARRIER.** There are no exceptions.

NO DOGS ALLOWED IN STALLS

13. MEDICAL WASTES: Dispose of needles and syringes in labeled containers at wash racks. Please use aseptic techniques for safety. ARTICLE 1210.5 Competition management may fine any individuals including trainers, owners, exhibitors, or their agents up to \$100 for improper disposal of needles or other sharp disposable instruments. Containers can be found at every wash rack, please notify management if one needs to be attended. **Rule 1210.4**

14. GOLF CARTS AND MOPEDS: Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which the reside will not be permitted to operate a motorized vehicle of any kind including but not limited to golf carts, motorcycles, scooters or farm utility vehicles on the competition grounds of licensed competitions. Minors who have a valid temp license may operate the above motorized vehicles as long as they are accompanied by an adult with a valid driver's license. Violations of this rule will cause for sanctions against the parent(s) and/or guardian(s) and/or trainer(s) who are responsible for the child committing the offense. Wheelchairs & other mobility assistance devices for individuals with disabilities are exempt from this rule.
