* For Scores to count towards qualifying for Great American/USDF Regional Championships, add \$10.00 USDF fee to class fee and indicate with a "Q" behind the class name on your entry form. (Test of Choice classes may not be used for qualifying.)

** Adequate Sound system available, cassette or CD. Mail your test sheet from the highest test, 60% or higher in an USEF show with your entry.

*** **Opportunity Classes:** Riders/Horses competing only in "opportunity" classes are exempt from USEF/USDF membership requirements and do not have to pay NM, HID or USEF drug fees. In addition, owners, trainers & coaches are exempt from membership requirements for these classes. While membership requirements are waived for riders in "opportunity" classes, all USEF Dressage Division rules apply (including dress & saddlery requirements), in addition to all applicable General Rules such as Drugs & Medications. "Opportunity" riders & horses may cross enter into non-opportunity classes, but if you do so, all USEF/USDF membership requirements & fees will apply. Scores earned in "opportunity" classes may not be used toward USEF/USDF awards or programs.

2. AWARDS: 1st thru 6th place ribbons and 1st place awards with 3 or more entries.

3. ENTRIES: Intro thru Fourth & Opportunity - \$45; FEI & Freestyles - \$65; Qualifying Fee \$10; Office Fee per horse/rider combination - \$25; USEF Drug Fee \$16; Non competing horse (schooling) \$25; Late entry fee \$10; each non USEF rider/trainer/owner must pay a \$30 non-member fee, each non USDF rider/owner must pay \$25 non member fee; plus stall fee as below. Entries will not be accepted unless full payment of all fees plus certified copy of current coggins test, USDF/USEF member numbers and all releases properly executed and signed on entry form.

4. TIMES: Will be emailed and posted on web site www.foxleafarm.com about 1 week before the show.

5. STABLING: 254 permanent stalls with doors are available. Stalls are 10X12 and 12X12. No first bedding is provided. Straw bedding is not permitted. Stall assignments at discretion of management. Shavings available on grounds \$7.75 a bag. SHOW FEE: \$100 from noon day preceding show to show's end. Extra nights \$24. Show stabling rates of \$67 will apply to horses already boarding at Fox Lea Farm that are participating in show. All horses must be stabled. No dogs allowed in stalls. **NO EXCEPTIONS**

7. CAMPER SPACE: Electric & water, no septic-30 AMP \$37.50/night, 50 AMP \$47.50/night

8. FOOTING: All arenas 20 X 60 meters. 4 sand with screenings. Ample warm-up.

9. DIRECTIONS: I-75, Exit 193(old exit 35)(Jacaranda Blvd). Turn right second light onto E Venice Ave. Turn right one mile onto Auburn Rd 1.2 miles on right

10 HOSPITALITY: Concession stand on grounds throughout show, breakfast available. Special events will be posted.

12.PETS: If a pet is brought to the show grounds, **IT MUST BE CONTAINED ON A LEASH OR IN A CARRIER.** There are no exceptions. **NO DOGS ALLOWED IN STALLS**

13. MEDICAL WASTES: Dispose of needles and syringes in labeled containers at wash racks. Please use aseptic techniques for safety. ARTICLE 1210.5 Competition management may fine any individuals including trainers, owners, exhibitors, or their agents up to \$100 for improper disposal of needles or other sharp disposable instruments. Containers can be found at every wash rack, please notify management if one needs to be attended. **Rule 1210.4**

14. GOLF CARTS AND MOPEDS: Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind including but not limited to golf carts, motorcycles, scooters or farm utility vehicles on the competition grounds of licensed competitions. Minors who have a valid temp license may operate the above motorized vehicles as long as they are accompanied by an adult with a valid driver's license. Violations of this rule will cause for sanctions against the parent(s) and/or guardian(s) and/or trainer(s) who are responsible for the child committing the offense. Wheelchairs & other mobility assistance devices for individuals with disabilities are exempt from this rule. **See Rule GR901.29**
